1. 2. On approval, we will keep this EMD amount with us and will adjust/transfer directly to the Seller at the time of final lifting. **EMD of second highest Bidder will remain with us for 20 working days and they may be asked to honor the deal in that time at their bid amount.** Second buyer will have to honor the deal at his bid amount and if he refuses to proceed with his bid, his EMD will also stand forfeited.
4. EMD's of other bidders will be returned in 7 working days after completion of the bidding event. EMD will not attract any interest.
5. Bidders (H1 & H2) bid should be valid for 20 working days until the H1 Bidder starts to lift the Material.
6. 7. The highest bidder/offer does not get any right to demand acceptance of his offer. SELLER reserves the right to accept / reject / cancel any bid, withdraw any portion of the Auction Property at any stage from Auction even after acceptance of bid / issue of delivery order or release order / deposit of full value by successful bidder without assigning any reason thereof. In the event of total rejection / cancellation / withdrawal, SELLER, shall refund the value of Auction Property (including EMD), if paid for, to the successful bidder. SELLER shall not be responsible for any damages / loss whatsoever to the successful bidder on account of such withdrawal.
8. Lifting will be carried out as per the instructions given by the Seller (like more damage material will lift first) against payment made in advance. Materials must be removed (after making payments with GST and TCS (if any) on or before due date, failing which the contract will automatically stand terminated and the Earnest Money Deposit will stand forfeited for the breach of contract by the purchaser.
9. Purchasers are requested to follow all safety rules applicable or given by the seller at the time of lifting.
